

Content Creator Content Creation Agreement and Non-Disclosure Agreement (NDA)

This Content Creator Content Creation Agreement ("Agreement") is entered into on this 07/10/2023, by and between:

1. Scope of Services

1.2 Ownership: The Content created by the Content Creator for the Company shall be the exclusive property of the Company. The Content Creator hereby assigns all rights, title, and interest in the Content to the Company, including but not limited to copyrights and any other intellectual property rights.

2. Compensation

2.1 Payment: In consideration for the Content creation services, the Company agrees to provide the Content Creator with Equipment's like Camera, Lights, Microphones and Place to Shoot her Content Until she is Working with Space and Tech Engineering LLP as compensation for each piece of Content created, subject to the terms and conditions of this Agreement.

3. Equipment and Resources

3.1 Provision of Equipment: The Company shall provide the Content Creator with access to necessary equipment, tools, and resources required for the creation of Content, including electronic components, devices, and a designated workspace, as agreed upon by the Parties.

4. Confidentiality and Non-Disclosure

5.1 Term: This Agreement shall commence on the Effective Date and shall continue until terminated by either Party upon written notice to the other Party.

5.2 Termination for Convenience: Either Party may terminate this Agreement at any time and for any reason with 7 days' written notice to the other Party.

5.3 Termination for Cause: Either Party may terminate this Agreement immediately in the event of a material breach by the other Party.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Republic of India.

7. Entire Agreement

This Agreement contains the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties.
